A message from Jack Rushing at Alliant Insurance Services

This is a recent development I believe all Chamber members should be aware of: [Businesses eligible for new insurance subsidy](#)

During last fall's special legislative session, a \$15 million small business premium subsidy for firms with between two to nine employees was created. The program works with private insurance companies and pays between \$100 and \$5,000 in employees' annual health insurance costs based on their income and type of insurance. The subsidy will not cover more than half of annual premiums and is not open to businesses that have a current health insurance plan in place.

Please spread the news and if I can be of assistance to any member companies in interpreting the subsidy and its requirement I would be more than willing.
